- **Energy**: The vibrant energy associated with red reflects the proactive approach that Nivaaran takes towards resolving disputes, emphasizing the vitality and strength needed to mediate difficult situations.
- **Determination**: Red stands for resilience and determination in achieving just outcomes. Mediation requires patience and persistence, traits that are embodied by the red colour, underscoring Nivaaran's dedication to seeing each resolution process through to the end.
- In the context of justice, red is also a universal symbol of advocacy. It communicates a sense of urgency and action, aligning with Nivaaran's role in intervening and mediating pre litigation conflicts and post litigation disputes with a sense of responsibility and purpose.

Blue Colour represents a sense of trust, peace, magnanimity without limitations, and harmony—essential values that form the foundation of effective mediation and conflict resolution.

the sense of security that Nivaaran fosters in the mediation process. As
mediators, trust between the parties involved is crucial, and blue reflects the

- Magnanimity without Limitations: Blue also symbolizes wisdom, fairness, and the ability to exercise magnanimity—demonstrating generosity of spirit without constraints. It reflects the balanced and fair approach that Nivaaran mediators take, helping both parties reach a compromise while remaining committed to the principles of justice. This magnanimity fosters an atmosphere of understanding and goodwill, encouraging resolutions that are not only fair but compassionate
- **Harmony**: Finally, blue represents harmony and balance. In mediation, the goal is to restore equilibrium between conflicting parties. Blue symbolizes the creation of a harmonious environment where disputes are resolved amicably and relationships are preserved.
