THE TWENTY-FIRST CENTURY HAS WITNESSED UNPRECEDENTED ADVANCES IN LAW, TECHNOLOGY, AND GOVERNANCE. YET SOCIETIES ACROSS THE WORLD CONTINUE TO CONFRONT DEEPENING POLARISATION, INSTITUTIONAL DISTRUST, TRANSNATIONAL CONFLICTS, ENVIRONMENTAL CRISIS, AND INCREASINGLY COMPLEX DISPUTES THAT TRADITIONAL ADJUDICATORY SYSTEMS ALONE CANNOT FULLY RESOLVE. AGAINST THIS BACKDROP, A DEFINING QUESTION EMERGES: CAN PEACE ITSELF BECOME A FOUNDATIONAL PRINCIPLE OF JUSTICE RATHER THAN MERELY ITS DESIRED OUTCOME?

THE COMMONWEALTH PEACE MEDIATION CONFERENCE 2026 BRINGS TOGETHER AN EXTRAORDINARY ASSEMBLY OF JUDGES, JURISTS, ARBITRATORS, MEDIATORS, POLICYMAKERS, DIPLOMATS, SCHOLARS, AND TECHNOLOGY LEADERS FROM ACROSS THE COMMONWEALTH TO EXPLORE THAT QUESTION.
